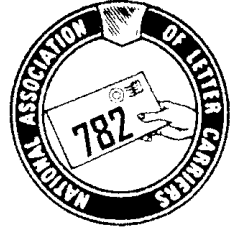

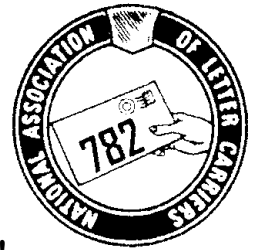
Branch 782 has chartered a bus for the event to make it easier for our members to be a part of this important chance to state our case.

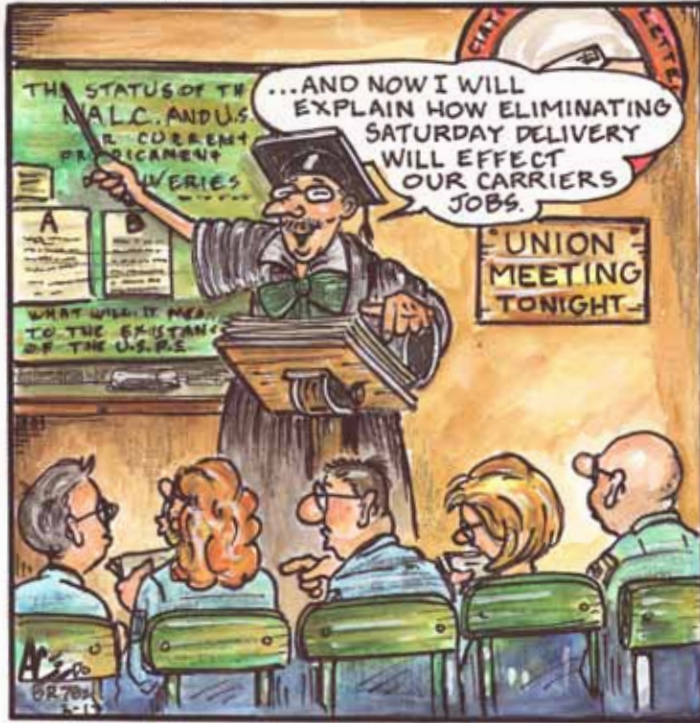

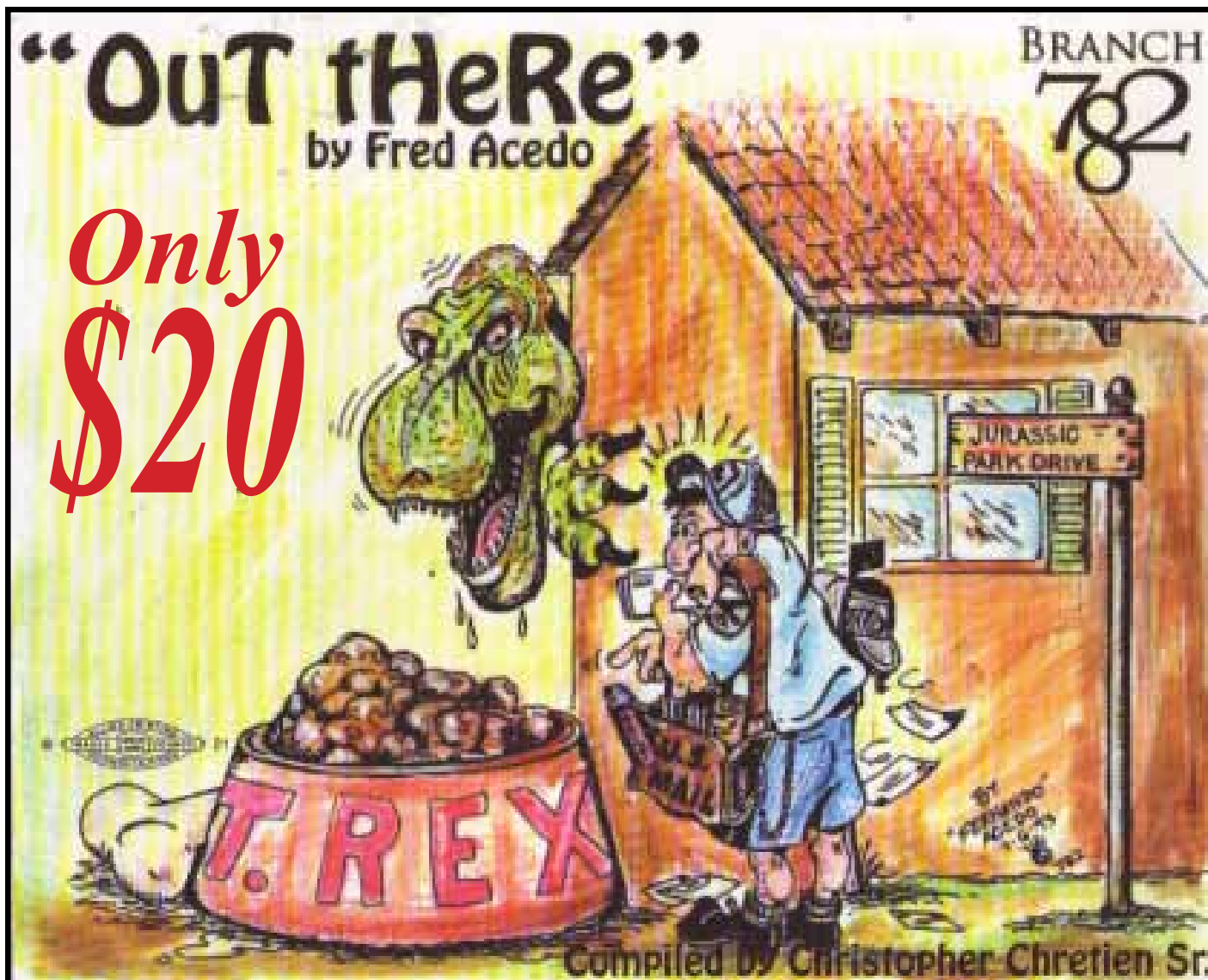

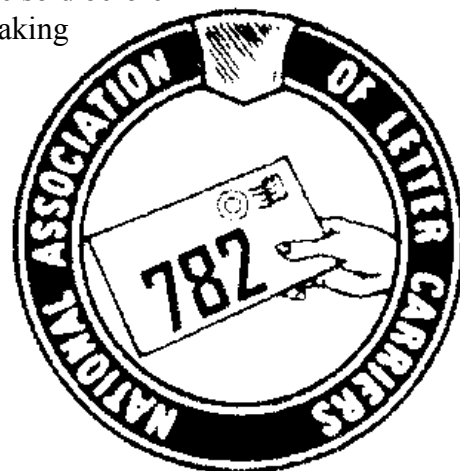
So what is this advertising message about? **THIS** is an MDA fundraiser. We are asking for **YOUR** help!!!!!!

# Johnny on the Spot



**While the Postal Service moves forward with it's 5-day delivery fiasco, the Senate is currently considering a move to block the plan to end the Saturday delivery of mail.**

A provision to keep Saturday mail delivery is being considered as part of a Senate budget resolution, it is similar to legislation that the House passed last week. There is no law that requires the Postal Service to deliver mail six days a week.

However, a spending bill that reimburses the agency for providing mail service to the blind and ballots to overseas voters *does* require six days of mail delivery. The provision has been in the annual spending bills since 1983. The Postal Service says the current continuing resolution does not include “specific language” requiring it to deliver mail 6 days a week.

Many lawmakers have expressed frustration with PMG Donahoe, who they say is trying to make an end run around Congress. But our worst two enemies—Senator Tom Coburn, Republican of Oklahoma, and Representative Darrell Issa, a Republican from California—said the five-day delivery schedule was a “common-sense reform.”

Mr. Issa added that because the Postal Service would continue to deliver packages and keep post offices open on Saturday, the agency would simply be altering the services it provides and would not be in defiance of the spending provision that requires six-day delivery. This is the BS they are feeding their fellow GOP members.

He is also telling PMG Donahoe that if Congress does come up with a 6-day mandate to deliver mail that the Postal service can sidestep it by not accepting the roughly \$100 million in appropriation's funds the USPS receives for free matter for the blind and overseas ballots for voters.

March 27th 2013 is the date the current continuing resolution requiring 6-day delivery expires. In response to this, the NALC has planned a national rally day in support of 6-day delivery on March 24th 2013. Members of our Branch will be attending a rally in Fresno from 11a.m. until 2 p.m. Branch 782 has chartered a bus for the event and NALC headquarters is helping out our Branch with \$750 towards the cost of of this investment.

As of the writing of this article, we have almost sixty people committed to committing their time and energy to this event.

This is what a Union is about... Our voice will be heard!

dent of the United States. Then there is the Postal Board of Governors and the Postal Regulatory Commission and, of course, let’s not forget the Department of Homeland Security.

So, you can see it’s complicated.

Then there is the American public—the *true owners of the Postal Service*. How can we overcome all this and stop the madness coming from L’Enfant Plaza in Washington D. C.?

As I mentioned previously, we have many layers to the oversight of this organization and the American public is the first and in my mind., First and foremost we have to educate and convince that the PMG is bad for the Postal Service and bad for America. Once we do this, we—along with the American public—will focus on Congress and the Postal Board of Governors to make them see the error of the PMG’s ways.

I know that we have heard this drum beat many times before. It seem to be only a small number of Letter Carriers who answer it. We have been successful thus far. Moreover, those who sat on the sidelines have the feeling that “those NALC folks” did it without me then, so they can do it without me now.

You have never been more wrong! We need *every* Carrier and their family, who in turn needs *every* American, who in turn needs *every* Congressperson..... You get the picture.

If you have not lifted a finger to save your job thus far, now is the time to go all in. If you have rallied and have written your elected representative or made that phone call, **now we need to re-double our efforts!** The NALC got you a contract. Now, it’s up to you to save the Postal Service so that contract means something.

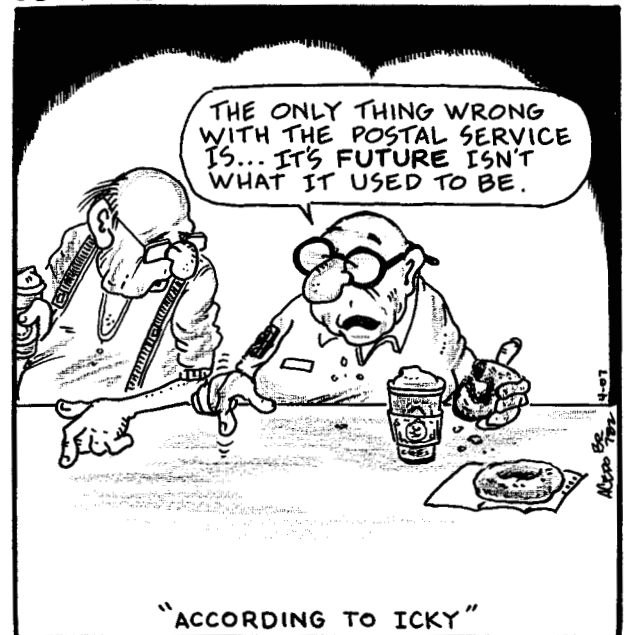
Come on out on March 24th and be heard. Show the American public that the Postal Service is theirs and that we are worth fighting for.

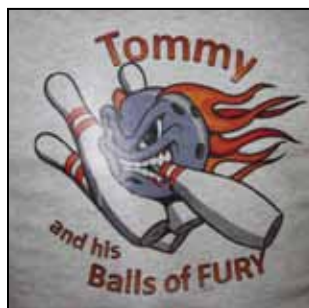

# It's Great to Have Weekends Off?

Hello, brothers and sisters. It's been awhile but I'm back. It's been a long time since my last article, and many rumors have been buzzing during this time. We heard about the plan to close processing plants, retail stations, and some delivery units. We also heard about the plan to excess Letter Carriers and Clerks to different crafts and other installations. The alarming thing about some of the rumors that we have been hearing is that they are becoming a reality, with more to come down the road.

Letter Carriers have been excessed into other stations and other crafts, which traumatically changed their lives. Some Carriers are forced to drive as far as 100 miles from their regular assigned installation to the new installation. Other Carriers were not only excessed from their assigned installation, they were also excessed into other crafts. Keep in mind that when Carriers are excessed they become junior in seniority in the new installation or craft. Yes, that means the bottom of the barrel in that office.

We have heard about the Postmaster General's plans to eliminate first class mail delivery on Saturdays beginning August 5, 2013 however, we have not heard about plans on how it will affect the Letter Carriers assignments, work schedules, and T-6 positions (Note at the time this article was written).

Some of our fellow brothers and sisters were happy and excited to hear the news of the plan to deliver first class letters and flats only 5 days a week with the possibility of having weekends off. Unfortunately I deflated their excitement when my opinion was asked about having weekends off if the plan goes into effect. I explained that it may be a possibility that some of the Letter Carriers may not only have weekends off, but they may also have every day off. Example: Under the new Contractual Agreement all Part-Time Flexible Letter Carriers will be converted to Regular Letter Carriers by May 2016. Under the Contractual Agreement Regular Letter Carriers are guaranteed 40 hours a week. If the Regular Letter Carriers schedule is changed to a five day work week it may eliminate the need for the T-6 position. Therefore, the five day work week may cause an excess of unassigned Regular Letter Carriers due to the lack of available work and assignments. This may lead to the need to excess the junior unassigned Regular Letter Carrier(s) into another craft or installation if there is no work available in their assigned craft or installation. In addition, this may also lead to the possibilities of LAYOFFS.

This is one of the reasons why it is important to support the NALC actions to defeat the Postmaster General's plan of action. We need to be on alert and pay attention to what is happening to the Postal Service because some of these rumors may become reality. Letter Carriers may have to be prepared to make adjustments and step up to take the appropriate necessary actions to help secure our jobs. We all should make contributions to COLCPE to support the political men and women that support Letter Carriers and their families. Write to your Congressmen and let him/her know the importance of maintaining 6 day delivery for all MAIL!

Some may say awh, that's just a rumor. Well, go back and read the beginning of this article, remember some rumors may lead to becoming a reality. I don't mean to rain on anyone's parade. I think it will be great to have weekends off, however I have to be honest and put things in perspective. I don't need weekends off at the expense of Letter Carriers losing their jobs.

In closing, I believe that these are some scary times for many Letter Carriers and some of our members may have a tough time dealing with all the changes at the Postal Service. I'm confident that the NALC will do all it can for the best interest of Letter Carriers. The NALC will utilize the same effort that was presented to the Arbitration panel that decided our current contract with the Postal Service to secure our jobs.

Just a reminder to all, if you are having difficulties at work or at home, and you need to talk to someone in private, EAP is there for you and its free to all Postal Employees and his/her immediate families (1-800-EAP-4-YOU).

## Report: Struggling Postal Service to spend \$2.2 million on San Francisco conference

The struggling United States Postal Service, which has been pushing to end Saturday deliveries as a last-ditch way to save money, is spending over \$2 million to send 400 employees to a San Francisco conference next month.

Documents obtained by local California TV station KTVU reveal that Postal Service will end up spending \$2.2 million on the four-day National Postal Forum conference at the Moscone Center in March.

KTVU reports that between travel, exhibit space and other aspects of the trip will cost the postal service \$2.2 million. There will also be workshops, golf, a dance party, music entertainment, and a taste of San Francisco banquet, according to the report.

USPS explained to KTVU that the Forum will help to make money by creating future business, claiming that last year the Forum conference in Orlando generated \$73,000 for each dollar they spent.

"The Forum is the mailing industry's premier educational venue, trade show and networking event for industry professionals," The National Postal Service Forum's website explains. "It provides business mailers with ongoing training and education, and helps them keep pace with the mailing industry's rapid progress."

USPS added that this year they as sending 160 fewer staffers than they did last year.

The Forum is held annually each spring.

**UPDATE:** Tuesday, Georgia Republican Rep. Tom Graves sent a letter to Postmaster General Patrick Donahoe requesting a "detailed justification for the USPS's costly participation in the National Postal Forum conference.

# Misinformed Public

To help prevent a misinformed public from standing idly by while the U.S. postmaster general begins to dismantle the Postal Service, I offer the following facts and observations.

Debt troubles for the USPS began in 2006 when Congress enacted a mandate requiring the agency to transfer \$5.5 billion annually from its operating budget into a future retiree health benefit fund. At the same time, Congress made it impossible for the agency to change its rate structure or enter new lines of business to pay for the mandate. The measure targeted no other federal agency or private firm — only the USPS, even though its future benefit accounts were already well funded and growing.

Congress thus manufactured a financial crisis for the USPS, made worse by the onset of recession shortly thereafter and the drop off in first-class mail. At least 80 percent of the current postal debt can be attributed to the pre-funding mandate, according to the National Association of Letter Carriers.

You may be surprised to learn that in its latest fiscal quarter, despite a slack economy, the USPS earned a profit of \$100 million delivering the nation's mail. It earned \$17.7 billion in revenue against \$17.6 billion in operating expenses. The profit was due largely to a jump in its package delivery and gains in efficiency. Many media outlets reported the quarterly results as a \$1.3 billion loss for the Postal Service, without making it clear that the loss was due to the quarter's \$1.4 billion prefunding charge.

The Postal Service has received no taxpayer funding for more than 30 years and does not require a taxpayer bailout to overcome the financial crisis imposed on it by Congress. It requires that Congress remove the pre-funding mandate and allow the agency to rationally use its own funds.

Further, it needs to take the handcuffs off the USPS and allow it to innovate, to develop new services and products to support its constitutional mission to serve us all (rural and urban, rich and poor) with a dependable, univer-

sal and affordable postal service. It does not need a postmaster general who lacks an effective strategy to save and strengthen the system.

The postmaster general's recent unilateral and unwise proposal to save money by cutting mail delivery to five days cannot be implemented without congressional approval. In the last Congress, a bipartisan majority of representatives co-sponsored legislation to maintain Saturday delivery. In the new Congress, Maine Reps. Mike Michaud and Chellie Pingree have joined with others who are signing up to co-sponsor H.R. 30, which supports Saturday delivery.

In Maine and other rural states, small and home businesses predominate. My career experience as a city letter carrier leads me to believe that many of these businesses would be harmed by taking back their mail — remittances mostly — on Saturdays. Overwhelmingly, small businesses receive payment by mailed check. The Postal Service should not be allowed to slow the mail and disrupt that cash flow.

Senate majority leader Harry Reid (D-Nevada) stated, "Given the importance of the Post Office to communities in Nevada and across our nation, such a drastic policy change cannot be enacted without approval from Congress. Instead, the Postmaster General relied on flawed legal guidance to claim that he can circumvent Congress' authority on the matter. The Postmaster General's actions have damaged his reputation with congressional leaders and further complicates congressional efforts to pass comprehensive postal reform legislation in the future."

The USPS is using misleading polling numbers to claim public approval for its action. A company spokesperson told the BDN on Feb. 7, "There have been multiple surveys done. ... Upward of 70 percent supported the move to five-day delivery if that means there won't be any taxpayer funding."

The question is deceptive — there is no proposal in Congress to support the USPS with taxpayer funds. Results

of opinion surveys always depend on how the question is phrased. What if pollsters had asked, “Would you support ending Saturday delivery if it led to the further dismantling of universal, affordable postal service and its replacement with a patchwork of expensive services offered by private firms?” I suspect that upwards of 70 percent of respondents would disapprove.

Further, the postmaster general’s claim that the cut will save the agency \$2 billion is also unreliable and has been questioned by Sen. Susan Collins and others.

In announcing the end of Saturday mail, Postmaster General Donahoe is basically gambling that Congress will not include the 6-day mail delivery requirement in whatever new appropriations bill it passes before March 27 2013.

Strong and timely action is undoubtedly needed to save the USPS. That means ending the pre-funding mandate. It does not mean recklessly halting service, which will only shrink revenue and lead to further cuts, leading to even less revenue — a downward spiral ending in the death of the Postal Service.

## Statement of NALC President Fredric Rolando on Postmaster General Pat Donahoe’s plan to eliminate Saturday mail delivery

Feb. 6, 2013 -- Postmaster General Patrick Donahoe’s plan to end Saturday delivery is a disastrous idea that would have a profoundly negative effect on the Postal Service and on millions of customers. It would be particularly harmful to small businesses, communities, the elderly, the disabled and others who depend on Saturday delivery for commerce and communication.

Slowing mail service and degrading our unmatched last-mile delivery network are not the answers to the Postal Service’s financial problems. If the Postmaster General is unwilling or unable to develop a smart growth strategy that serves the nearly 50% of business mailers that want to keep six-day service, and if he arrogantly thinks he is above the law or has the right to decide policy matters that should be left to Congress, it is time for him to step down.



This maneuver by Mr. Donahoe flouts the will of Congress, as expressed annually over the past 30 years in legislation that mandates six-day delivery, which remains in effect today. In the last Congress, which ended in January, a bi-partisan majority of Representatives co-sponsored legislation backing the continuation of Saturday delivery.

This misguided and counterproductive decision is in keeping with the Postmaster General’s slash-and-shrink approach to dealing with the Postal Service’s financial challenges. Instead of offering a real business plan to tap the full potential of this essential American institution, he is offering a plan that will doom USPS to failure.

The National Association of Letter Carriers has tried time and again to work with Postal Service management to pursue growth measures and cost savings, but it has become clear that the Postal Service leadership’s only strategy is to gut the unique postal network that provides us with the world’s most affordable delivery service, and to eliminate the services on which Americans depend.

America’s letter carriers condemn this reckless plan in the strongest terms. We call for the immediate removal of the postmaster general, who has lost the confidence of the men and women who deliver for America every day. And we urge Congress to develop a real reform plan that gives the Postal Service the freedom to grow and innovate in the digital era.

# Senior Vice President's Report

What information can you provide a non-union member to convince them of the need for a strong union and why they should be a member of the NALC? A good place to begin would be in the Arbitration Award for our new National Agreement. The new contract contains three general wage increases during the life of the contract; 1 percent in November 2013, 1.5 percent in November 2014, and 1 percent in November 2015. It also contains seven COLAs to be paid between now and 2016, though the two COLAs calculated in 2013 will be deferred and paid in 2014.

In addition, the contract maintains the ban on sub-contracting and the no-layoff clause for carriers with at least six years of service. And, although the award lowered the entry wage for new career letter carriers (appointed on or after Jan. 12, 2013), these new carriers will reach the top step pay of the existing pay chart in exactly 644 weeks, the same 12.4 years that applies to career carriers appointed before Jan. 12, 2013.

And while these achievements are certainly a good starting point, perhaps the best argument for a strong union is made by management. These are some of the arguments management presented to the Arbitration Board, and are included in the Arbitration decision:

*The Postal Service has experienced an unprecedented and permanent decline in First Class mail revenue due largely to electronic diversion. This fact, combined with certain regulatory burdens imposed by Congress, has led to a dangerous and untenable financial situation for the Postal Service-one that cannot be solved by*

*Congressional action alone. As the delivery network continues to grow while the value of the product delivered declines, the Postal Service must bring its delivery cost structure in line with its declining revenues.*

*As the Postal Service seeks to generate new revenue in response to the dramatic, permanent loss of First Class mail volume, it will move increasingly into the packages and parcels market, which is intensely competitive. The growth of e-commerce has led to a large increase in demand for low-cost same-day or next-day delivery in the business-to-consumer market. To effectively compete for this business, the Postal Service needs a less expensive delivery workforce with increased flexibility to deliver outside the typical 9- to-5 delivery window.*

*City delivery is significantly more costly than both rural delivery and contract delivery service; indeed, it is the most expensive cost center within the Postal Service. The Postal Service needs a less expensive delivery workforce to (1) ensure the gap between cost and revenue per delivery does not continue to grow, and (2) position the Postal Service to be competitive as it moves further into the same-day and next-day package delivery markets.*

*City letter carriers enjoy a very rich and very costly wage and benefit package that exceeds comparable wages and benefits paid for similar levels of work in the private sector. The appropriate comparison for purposes of private sector comparability is the entire private sector, not only large, unionized employers. Past interest arbitrators have recognized the postal wage premium.*

*Collective bargaining does not exist in a vacuum, and must take into account financial realities and changes in product markets. Provisions such as COLA clauses, no-layoff protections, and restrictions on contracting*

*are nearly non-existent in private sector labor contracts today. Accordingly, they should be excised from the parties' agreement.*

What did management ask the arbitration board to "give" you? Lower wages, no COLA clause, no-layoff protection, the right to contract out the work you do. That your wages and benefits be comparable to similar levels of non-union workers in the private sector, like pizza delivery drivers or a newspaper delivery person.

Any city letter carrier that can read the above arguments from management and still conclude the NALC is not doing anything for them is simply not living in the real world. Without the collective bargaining rights that we enjoy, management would not have to make the above arguments to an Arbitration Board, they would simply be able to implement the changes unilaterally.

I don't believe that any non-member can honestly say the benefits they enjoy as a result of union representation do not far outweigh any perceived problem, concern or dispute they may have with the union. While non-union members can give you a hundred and one reasons why they are not members, the only realistic reason for them not being union members is that they enjoy the free ride they get to take on the backs of hardworking, dues paying union members. The hardworking, dues paying union members who enable them to continue to enjoy the wages and benefits they enjoy because the NALC was able to present a case to the Arbitration Board to convince them that city letter carriers deserved a much better deal than the Postal Service was offering.
