## The Battle Continues

Not very long ago, PMG Patrick Donahoe conducted one of his weekly service talks stating the Postal Service would be going to 5-day delivery in the very near future. Our response: NO WAY!

The NALC staged rallies across the country in opposition to this "shrink to survive rationale".

Locally, Branch 782—with assistance from NALC headquarters—chartered a bus to Fresno, CA to attend the Rally staged there. We filled the bus along with some members from Visalia. Other Branch 782 members who drove their own vehicles filled the rally with our supporters. The result was that 6-day delivery was preserved. The media coverage we received was tremendous. The support we received from the public was overwhelming. And, in the end, I truly believe that the Postal Regulatory Commission (witnessing the outcome of our actions) ruled in our favor that it was against the law for the Postal Service to unilaterally shift to 5 day delivery.

Game Over, right? Not exactly!!

Our "frenemy" Rep. Darrel Issa, Chair of the House Oversight Committee, which governs the Postal Service has TWICE attempted to write legislation that would allow the Postal service to go to 5-day delivery.

So how have **WE** thwarted two attempts? The answer is WE!! Members of the NALC Carrier Corps have been the force that has stopped these attempts in their tracks. It is very easy to sign up for the NALC Carrier Corps. Log onto the NALC.org website and sign up. IT IS FREE! You will receive important emails when issues arrive concerning our livelihood. More importantly, it is so easy to respond to these attacks, especially in this smart phone era. Usually, all you have to do is enter your name and click on the petition. Your Congressional Representative will see your opinion to the matter at hand. There is power in numbers.

Another way to really get involved is through our COLCPE program. This program is not free but is so crucial to giving us a voice on the Hill. The best part is you decide what to invest. There is no donation too large or too small. Deductions can be through payroll deduction or a one-time donation. It should not matter what side of the aisle you are on. ## When Politicians Threaten Your Livelihood, Take Them At Their Word!

uring the 2012 election season, a relative asked me who I supported for president. When I replied that I planned to campaign for President Obama, she replied with disbelief. I explained that Mitt Romney supported a pay cut of forty percent for federal and postal employees and also advocataed for selling off the post

orty es post

office and its assets, as he had done with other enterprises. Her reply was, "He doesn't mean it. He won't do that."

Back to 2010, when House Republicans were in the minority, they published a policy paper which stated that federal/postal employees should contribute more toward their pensions and it further stated that the special retirement supplement under the Federal Employees Retirement System (FERS) should be abolished. This would effectively raise the minimum retirement age from 56/57 (depending on the year you were born) to 62.

And guess what? Legislation signed into Law forces new FERS employees to pay 4.4% of their base salary toward their pensions—up from .8%. House Republicans have also passed legislation eliminating the special retirement supplement, and Paul Ryan includes such a provision in his budget blueprint.

Senator Rand Paul proposed an amendment to S. 1789 which would have ended the mailbox use monopoly. Three quarters of Republican senators (35 of 47) voted to privatize the mailbox. This would allow any Tom, Dick or Harry to stick his hand in your patron's receptacle.

And, then, there's 1980 Libertarian vice-presidential candidate David Koch who sits on the pro-privatization Cato Institute's

board of directors and gives tens of millions of dollars to politicians who favor outsourcing your job to private contractors. If you think think you can pay your bills carrying a contract route, think again. They make between \$15 and 20 thousand a year with no benefits. Can you make your mortgae payment or support your family on that?

The good news in this narrative is that you can do something about protecting what you have. You can participate in phone banks and precinct walks in support of pro-labor congressional candidates. You can call your Congress person or Senator when a harmful piece of legislation comes up for a vote and let him or her know how you feel. Better yet, get your friends and family to do likewise.

At this moment, there are at least three separate proposals to end 6-day delivery. Is this proposal just to save the USPS? Read what Crossroads GPS and Koch Industry money is flowing into politicians coffers. It is a means to their end.

Please participate in efforts to elect pro-Labor candidates! Your future depends on it.

I have to BRAG..... As I write this, there were **NO** bags left to be seen on Friday. *How AMAZING is that???* 







### Bonita Lewis is retiring!!!



eptember 4, 1993 was the day that Bonita birthed her postal career. In the next twenty years, most of her time was spent delivering mail to customers who live in the 93304 area serviced by South Station. She did spend about a year and a half at East Bakersfield and Dole Court.

When she walked through the door, she—like almost everyone else—had no idea what she was getting into. She had worked at a bank, but the industry was changing as banks were being bought out all over town by bigger institutions and she didn't feel that there was too much job security. She wanted to be able to retire and not have any fears of being unemployed.

The best part of the job, in Bonita's opinion, is the time that is spent out on the street. She didn't want to be cooped up in an office all day!

She also has some strong feelings about the worst part about being a Letter Carrier. "What I don't like is when people don't control their dogs. Simple commands like COME, SIT, STAY. Or, they don't socialize them and keep them chained up in their back yard without any people interaction. This only creates a dog that protects its property and surroundings with fear. I've had some very close calls out there with dogs and it's something that I don't wish on anyone.

It's perhaps one specific incident that was more than a "very close call" that underscores her strong feelings.

In 1998, she was bitten by a black Lab on the top of her right hand when she was delivering her route. There was nerve damage. Severed muscles have led to a pronounced loss of strength in her hand. (For perspective,

Bonita is right handed. Her right hand should be *MUCH* stronger than her left hand. When last tested, she squeezed 135 pounds with her left hand but only 25 with her right hand.) She learned to accomodate her injuries by using a nutting truck to move her mail from her case the LLV. Withdrawing trays from a deep hamper was too difficult with her hand issue.

When asked what she would miss the

most after she retires, she had a typical Bonita response: "First off, all my co-workers. It's amazing how much you learn abou your friends at work in the small amount of time we have in the office. South Station has a wonderful bunch of people that really care about each other. I wouldn't work at any office but South Station. I'll also miss my customers. They feel like family. Some could be described as 'quirky', but all-in-all, I still enjoy talking to them."

**BUT**, she won't miss a customer saying, "Oh, he won't bite...he's friendly." "Someone asked me once what dog on my route was my favorite dog. I

told them it was the one behind the fence! I do love dogs...but put them on a leash so I feel safe! I also won't miss making my lunch every day. I won't miss cleaning out the ice chest daily. I won't miss purchasing ibuprofen by the 100 tablet bottle and bandaids in the 100 variety box."

As Bonita steps out into her newest adventure, she admits that she won't be sitting around wishing she had something to do. "I have an Australian Shepherd that will be two years old in July of this year. He is currently on a Flyball team. In March of this year, he was in his first tournament. The next one will be in Santa Barbara at the end of June. I wasn't able to start any agility classes with him because they are held on Saturdays. One of my co-workers is going to join me at these classes. (Thanks, Brenda, for wanting to attend them with Tucker and me!)"

Bonita also likes gardening and plans to keep her flower beds free of weeds. "There's a few in there now, but after I retire I'm not going to have any excuse for that any more." She also anticipates that she's going to have more time to dedicate to another passion: "It will be nice to have my complete house clean at one time instead of 'just the kitchen and living room' or 'just the bathroom and bedrooms'!"


#### HILLCREST HAPPENINGS





## from the editor-guy

We—Letter Carriers—get such mixed messages. On the one hand, we're told what a great job we do. But, if we listen to the gloom and doom message that the USPS is pounding at the media, "we" suck and we are losing billions of dollars.

I want to offer a view written by David C. Yao, an APWU member. This info was sent to me by Jamie Partridge who is a retired Letter Carrier.

In a May 9, 2014 press release, the Postal Service issued another quarterly press release turning an operating profit (of \$261 million) into a loss. The supposed loss, an accounting fiction, was caused entirely by the 2006 law which generates a long-term loan to the Federal treasury, under the guise of "pre-funding" employee benefits.

In fact, the Postal Service is making a \$1 billion operating profit in the first six months of its fiscal year. In their own press release in response, the National Association of Letter Carriers pointed out that the Postal Service has been turning an operating profit since October of 2012.

But the USPS release included this apparent misstatement: "'revenue...was up \$379 million over the same period last year — the third straight quarter of revenue increase,' said Postmaster General and Chief Executive Officer Patrick Donahoe" (underlining added).

The Postal Service has actually been reporting revenue increases for five straight quarters, dating back to January 1, 2013. So why is Postmaster General Donahoe minimizing that winning streak? Perhaps someone in Postal HQ's statistics department was snoozing that day.

But there is a more disturbing explanation, that is consistent with the Postal Service's "doom and gloom" reporting of its finances. Over the last few years, faced with falling revenue, postal management has closed post offices, slashed rural office hours, sold historic buildings, cut jobs, and consolidated processing plants. It continues to seek closings and service cuts, such as eliminating Saturday delivery; but some of these moves have been delayed or curtailed by pushback from the public, from employees, and from legislators.

More recently however, postal finances have improved. Cash on hand increased from \$2.3 billion to \$3.7 billion over the last two quarters. Despite that, postal management has continued its campaign to impose austerity on the public (e.g., seeking to end door-to-door delivery), and its employees (such as current efforts to privatize its trucking arm and shift retail work to Staples). Its biggest weapon has been the persistent "We're Losing Billions" message.

So it appears more than suspicious that the PMG's press release minimizes postal management's own reports of increasing revenue over the past five quarters.

The persistent and misleading press releases about losses in the billions has also allowed right-wing commentators to paint a picture of the Postal Service as a failing business, even going so far as to call for privatization. But more importantly, they have the effect of drumming into the public, as well as employees, that drastic measures are called for, and there is no use in resisting.

In fact, postal reform *is* needed. But, not the slash-and-burn kind. Postmaster General Donahoe is apparently marching to the tune of big mailers, who want a streamlined network of postal facilities, without the costs imposed by the postal mandate of prompt and efficient universal service.

A postal management that took social values to heart, instead of corporate ones, would look to strengthen the Postal Service, not shrink it. Postal banking, for example, with a long history here and overseas, could provide valuable financial services to underserved areas and populations, as well as generate substantial revenue.

The U.S. government (or more specifically, a lame-duck Congress) is to blame for the Postal Accountability and Enhancement Act of 2006, which required that the Postal Service pump over \$55 billion into a federal treasury account—ostensibly for future retiree benefits— for the purpose of "pre-funding".

A history of pre-funding on savethepostoffice.com cites an analysis by the Inspector General of the USPS OIG: "The aggressive payment schedule appears to have been set based on byzantine 'budget scoring' considerations rather than actuarial assumptions or an evaluation of the Postal service's ability to make the payments." In other words, pumping money into the federal budget was the motivator, not future needs, and was made regardless of USPS ability to pay.

So the USPS cannot pay the \$5.5 billion per year now, previous payments having drained its credit line – so, what? No actual money changes hands, but it still counts as an asset in the federal budget, and it still counts as a debt in the postal budget. And thus, the phony losses that are reported by the postal press releases, and dutifully, if misleadingly, parroted by the media.

Equally important is that Congress does not want to eliminate the unneeded prefunding requirement, in this climate of budget fights. But what would be the harm in ignoring the annual \$5.5 billion dollar demand, "defaulting" as the Postal Service has done for several years, and carrying on as usual? Well, the harm is that this fanciful debt is being used as a battering ram to fool the public into thinking that postal finances are in such bad shape that a drastic overhaul is needed, as Representative Darrell Issa—the postal Voldemort—has been attempting to do.
